WHICH CONSISTS OF PAYING ALL OF THEIR BILLS, PROCESSING THEIR PAYROLL, PREPARING ANY AND ALL FORMS NECESSARY, AS WELL AS ANYTHING ELSE THAT NEEDS TO BE HANDLED BY AN ACCOUNTANT. THE REASON FOR THIS INCREASE IS DUE TO THE FACT THAT THE ORIGINAL PROPOSAL DID NOT INCLUDE THE COLLECTION OF PROPERTY TAXES. I PUT IN AN AVERAGE OF 35 TO 40 HOURS A WEEK. AT MY CURRENT RATES (\$25.00/HR) THIS WOULD NORMALLY COST YOU \$875.00 TO \$1000.00 PER MONTH.
