ORDINANCE No.1982-6. AN ORDINANCE
DEFINING DISORDERLY CONDUCT AND
PROVIDING FOR THE PENALTIES FOR
VIOLATION OF SAID ORDINANCE WITHIN

Section 1. The term "public place" as used in this
Chapter shall mean any street, alley, park, public
building, any place of business or assembly open
to or frequented by the public, and any other place
which is open to the public view or to which the
public has access.

Section 2. No person shall:

Be intoxicated in a public place and either endangering directly the safety of another person or of property or is acting in a manner that causes a public disturbance;

  2. Engage in any indecent, insulting, immoral or obscene conduct in any public place;
  3. Discharge any firearm, BB or pellet type rifle or pistol, bow and arrow in the Village, except when lawfully acting in the defense of persons or property or the enforcement of law or at a duly established range, the operation of which has been approved by the Village Council;

4. Engage in peeping in the windows of any inhabited place;
5. Utter vile, profane or obscene language in any public place;
6. Engage in fortune telling or pretend to tell fortunes for hire, gain or reward;
7. Make any immoral exhibition or indecent exposure of his person;
8. Print, engrave, sell, offer for sale, give away, exhibit or publish, or have in his possession for any such purpose any obscene, lewd, lascivious, indecent or immodest book, pamphlet, paper, picture, cast statuary, image or representation or other article of an indecent or immoral nature, or any book, paper, print, circular or writing made any book, paper, print, circular or writing made

up principally of pictures or stories of immodest deeds, lust, or crime, or exhibit any such article within the view of any passer-by;

9. Willfully destroy, remove, damage, alter or in any manner deface any property not his own, or any public building, bridge, fire hydrant, alarm box, street light, street sign, traffic control device, or tree belonging to the Village, or mark or post handbills on, or in any manner mar the walls of, any public building, or fence, tree, or pole within the Village, or destroy, take, or meddle with any property belonging to the village, or remove the same from the building or place where it may be placed, kept or stored, without proper authority; or disturb, tamper with, disconnect or damage any village water meter without proper authority;

10. Destroy, injure or in any manner deface any drinking fountain located in the Village, or throw or deposit any substance therein, or in any manner pollute the water in the basin of any fountain or detach the cups or other parts of such drinking fountain;

11. Insult, accost, molest, or otherwise annoy, either by word of mouth, sign, or motion, any person in any public place;

12. Engage in any disturbance, fight, or quarrel in a public place;

13. Collect or stand in crowds, or arrange, encourage, or abet the collection of persons in crowds for illegal or mischievious purposes in any public place;

14. Jostle or roughly crowd persons in any public place;

ce; Play any ball game in any public street or ewalk or otherwise obstruct traffic on any sidewalk or otherwise obstruct traffic on any street or sidewalk by collecting in groups thereon, for any purpose; 16. Loiter or conduct himself in any public place so as to obstruct the free and uninterrupted passage of the public;

17. Solicit or accost any person for the purpose of inducing the commission of any illegal or immoral act;
18. Disturb the public peace and quiet by loud,

boisterous, or vulgar conduct;

19. Permit or suffer any place occupied or controlled by him to be a resort of noisy, boisterous or disorderly persons;

20. Obstruct, resist, hinder, or oppose any member of the police force, or any peace officer in the discharge of his duties as such;

21. Trespass on the premises of any other person, without authority or permission of the owner of

without authority or permission of the owner of such premises;
22. Spit on any floor, wall, seat or equipment of any public place;
23. Wrongfully throw or propel any snowball, missle or object at or from any moving vehicle. Section 3. The provisions of this Ordinance are declared to be separable and if a word, sentence, clause, or provision should be declared unconstitutional and invalid, such adjucation shall not effect the remaining provisions of this Ordinance. dinance.

Section 4. Any Ordinance or Ordinances in-consistent with the provisions hereof are hereby repealed.
Section 5. Any person found guilty of being a disorderly person shall be punished by im-prisonment in the County Jail for a period not to exceed 90 days and/or by a fine not to exceed \$500.00. \$500.00.
