- 3. The Village Clerk shall publish this ordinance in a manner required by law. The public is hereby notified that a copy of the Uniform Traffic Code is available at the office of the Village Clerk for inspection by the public at all times.
- 4. Other ordinances in conflict here with relating to traffic are hereby specifically repealed.
- 5. <u>Penalty</u>. Every person, who is convicted of violating a provision of this code shall be punished by a fine of not more that \$100.00 and costs of prosecution or by imprisonment of not more than 90 days or by both such fine and imprisonment.
