**VIDE RETROACTIVE BILLING**  
**WHEN VILLAGE IS NOT NOTI-**  
**FIED OF A RESIDENT**  
**MOVE-IN.**

Section 1, Paragraph 5  
 a. When the village is not notified that a residence is now occupied and was billed at the stand-by rate of \$35.00 for water and upon the discovery of said occupancy, the village will retroactively bill back the difference between the stand-by rate and the full serve rate (\$45.00) of \$10.00 per month to the date the village was asked to put the residency on stand-by rates.

Section 1, Paragraph 6  
 a. When the village is not notified that a residence is now occupied and was been billed at the stand-by rate of \$35.00 for sewer upon the discovery of said occupancy, the village will retroactively bill back the difference between the stand-by rate and the full serve rate (\$45.00) of \$10.00 per month to the date the village was asked to put the residency on stand-by rates.

All ordinances or resolutions and parts of ordinances or resolutions inconsistent with this ordinance are hereby repealed.

This ordinance was approved and adopted by the Village Council on October 12, 2010. This ordinance will be effective on the day following its publication.
