

Village of Camden
Ordinance: 06-07

AN ORDINANCE TO PROVIDE FOR THE ESTABLISHMENT OF CHARGES BY THE VILLAGE OF CAMDEN FOR SERVICES PROVIDED BY THE CAMDEN FIRE DEPARTMENT WITHIN THE CAMDEN FIRE PROTECTION AREA.

The Village of Camden Ordains that

1. **Fire Service Rates.** The Village of Camden may establish charges for services provided by the Camden Fire Department which are within the Camden Fire Department protection area. The amount of such charges shall be established by resolution of the Camden Village Council and shall help to offset the cost of the services provided by the Camden Fire Department.
2. **Procedures for collection.** The Camden Village Council shall establish the billing methods and procedures. The Secretary for the Camden Fire Department will send a bill to the individuals receiving services that are provided.
3. **Ordinances in Conflict.** All Ordinances and parts of Ordinances in conflict with the provisions of the Ordinance are hereby repealed insofar as the conflicting portions thereof are concerned.

The Camden Village Council at its regular meeting held on March 10, 2007 adopted this ordinance. This ordinance shall take effect upon adoption of this ordinance.

RESOLUTION: ESTABLISHING CHARGES BY THE VILLAGE OF CAMDEN FOR SERVICES PROVIDED BY THE CAMDEN FIRE DEPARTMENT WITHIN THE CAMDEN FIRE DEPARTMENT FIRE PROTECTION AREA.

WHEREAS, Services provided by the Camden Fire Department are often eligible for insurance payment, and

WHEREAS, Camden Village Ordinance No. 06-07, provides for the establishment, by resolution, of charges of services within the Camden Fire Department protection area provided by the Camden Fire Department as well as any mutual aid given to other Fire Departments.

NOW, THEREFORE BE IT RESOLVED that the following charges are hereby adopted

Clean Up	\$200.00
Traffic Control	\$100.00
Volunteers	\$30.00 per hour
Incident Command	\$60.00 per hour
Extrication	\$600.00
Pumper if just present	\$100.00
Pumper if used	\$200.00 per hour
2000 gallon tanker if used	\$200.00 per hour
3000 gallon tanker if used	\$175.00 per hour
Equipment Van if just present	\$100.00
Equipment Van if used	\$200.00
Consumer's Energy or Any other Utility Company	\$850 plus hourly rates after one hour
2000 Gallon Pumper/Tanker	\$200 per hour
500 Gallon Pumper	\$200 per hour
3000 Gallon Tanker	\$175 per hour
Grass Rig	\$100 per hour
Incident Command	\$60 per hour
Volunteers	\$30 per hour
Carbon Monoxide Investigation	\$200 per run plus equipment & manpower hourly charges after one hour
Hazardous Material Spills	\$1000 per run plus equipment & manpower hourly charges after one hour
False Alarm / Fire/ Automated	1- free per year, each additional charged at hourly charges for equipment and manpower
Smoke Detector / Odor Investigation	\$200 per run plus equipment & manpower hourly charges after one hour

All incidents will be billed a minimum of one hour

All chemicals used and equipment / materials destroyed will be charged at their replacement costs

BE IT FURTHER RESOLVED that all resolutions and parts of resolution in conflict with the provisions of this resolution are hereby repealed insofar as the conflicting portions thereof are concerned.

BE IT FURTHER RESOLVED that the above schedule of charges shall be effective upon the adoption of this ordinance.
