



ON FEES.


THE VILLAGE OF CAMDEN HEREBY ORDAINS:

Section 1 of Ordinance No. ~~2007-05-07~~ 05-07 is hereby amended to provide the following
rates for the "Ready to Serve" fee, which was formerly known as the "Stand-by" rate, and provide
fees for the shut-off of service and the turning on of service as follows:

1. The Ready to Serve Fee for residential users in the Village of Camden who have requested
that their water service accounts be made dormant shall be \$15.00 per household per
month.
2. The Ready to Serve Fee for residential users in the Village of Camden who have requested
that their sewer accounts be made dormant shall be \$15.00 per household per month.
3. The Shut-off fee for residential users in the Village of Camden who request that their
water service be turned off shall be \$50.00 per household.
4. The Turn-on fee for residential users in the Village of Camden who request that their
water service be restored shall be \$50.00 per household.
5. All ordinances or resolutions and parts of ordinances or resolutions inconsistent with this
ordinance are hereby repealed
6. This ordinance was approved and adopted by the Village Council on January 8, 2008. This
ordinance shall be effective on the day following its publication

3. The Shut-off fee for residential users in the Village of Camden who request that their water service be turned off shall be \$50.00 per household.
4. The turn-on fee for residential users in the Village of Camden who request that their water service be restored shall be \$50.00 per household.
5. All ordinances or resolutions and parts of ordinances or resolutions inconsistent with this ordinance are hereby repealed.
6. This ordinance was approved and adopted by the Village Council on January 8, 2008. This ordinance shall be effective on the day following its publication.
